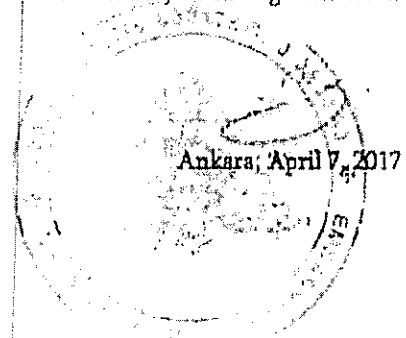

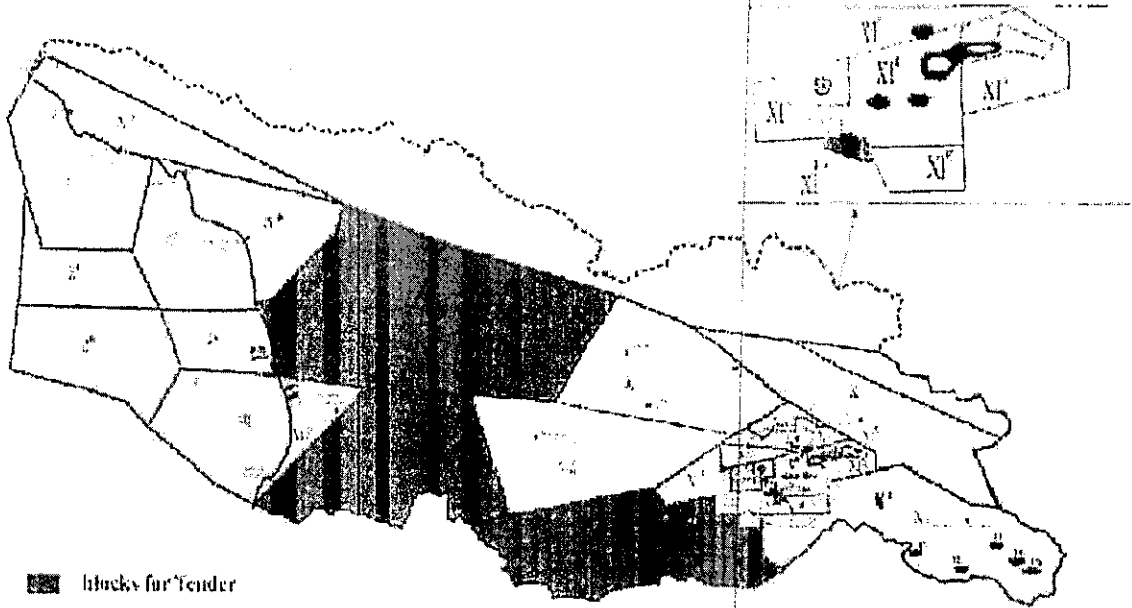
TENDER ANNOUNCEMENT

ADDITIONAL INFORMATION

The parties interested to participate in the Tender shall apply in writing to the Head of the State Agency of Oil and Gas. The State Agency of Oil and Gas will provide with DropBox link from where interested persons/companies can download Information Packages and/or CD with tender Information Packages to all interested parties without any charge but only at the office of the State Agency. In case requested, the State Agency of Oil and Gas will send tender Information Packages by express post only when such delivery expenses are prepaid by the requesting party.

The information packages will contain the following:

- a) General location and coordinates of the tracts;
- b) The sample of PSA Agreement applicable for each License Block;
- c) The minimum obligatory financial and technical terms for each License Block;
- d) The licensing and contracting schedule;
- e) The instructions for submitting bids, including the amount of the participation fee and payment instructions.
